Services to the community include the publication of the Government Directory and Voters Guide, registration of voters, information for new citizens, workshops, and public forums. Funds for these services come from membership dues, fund raising projects, and donations from individuals and businesses.

Membership is open to ALL persons over 16 years of age. Services include the local newsletter and frequent communication about local events.

## Register to Vote!

You may register to vote if you are a citizen of the U.S. for at least 1 month before the next election; a resident of Pennsylvania and your election district for at least 30 days before the next election; and eighteen (18) years of age on the day of the next election.

You can register **in person** at your county voter registration office, 1 Quaker Plaza, Room 105, Stroudsburg, weekdays 8:30 a.m. - 4:30 p.m. (closed weekends and holidays); or at the Department of Transportation photo license centers when applying for or renewing your driver's license.

You can register **by mail.** Voter registration mail applications are available at your county voter registration office; and at many other locations within each county including public libraries, universities, political party committees, and many service organizations.
