Minutes of the Meeting of the Board of Trustees Eastern Monroe Public Library

The regular scheduled monthly meeting of the Board of Trustees of the Eastern Monroe Public Library was held on June 16, 2015 at the Hughes Library.

The meeting was called to order at 8:33 AM by Board President, G Geiger.

W. Weitzmann moved to amend the minutes to show that he had not presented former Director Barbara Keiser with a virulent disease, but instead had given her a *plaque* upon her retirement.

S. McGraw/W. Weitzman moved to approve the amended minutes of the May 19, 2015 meeting. The motion carried unanimously.

President's Report –G Geiger recapped the June 16 meeting with Alan Burger, raised the idea of allocating \$2k to develop an architectural site plan, and S. Lyons noted that students from Marywood University might be available at some point in the future to undertake a similar project. Also the issue of possibly changing the name of EMPL was raised again. There was also discussion about producing an email newsletter, and about the possibility of setting aside \$2- or \$3K for equipment for TedX talks, tentatively scheduled for Oct. 17. S McGraw said he and G. Geiger would talk in the following weeks about trying to draw up a list of potential candidates.

S. Lyons also noted that the Hughes Foundation had provided \$140K grant to complete DRYVIT repairs at the Hughes Library.

Buildings/Property & Equipment. S. Miles said he needed to get a commitment from BESTucco of Allentown to warranty the DRYVIT work for 5 years and made a motion to offer the contract to BEStucco of Allentown. Seconded by W. Weitzmann. Passed Unanimously.

Treasurer's Report – W. Weitzmann presented the report. Noted \$892,208 in income, adding the library "is in good shape on taxes". Also expressed gratitude for the generosity of the Hughes foundation adding, "when we think about rebranding this place, we ought to think long and hard about this."

S. Miles/Tim Hegarty moved to approve the bills as presented. The motion carried unanimously.
